For purposes of Oracle Secure Mobile Identity Cloud Service, a transaction is defined as an operation initiated by the Oracle Cloud Service to complete a task related to any authentication, authorization, or identity verification task.

"1K Data Items Per Month" is defined as one thousand data items processed by the Oracle Cloud Service in a calendar month. For purposes of the Oracle Secure Mobile Identity Cloud Service, a data item includes the following: subscriber, device, network, and other attributes contained in a transaction, such as name, address, e-mail, national identifier, international mobile subscriber identity, international mobile equipment identity, external IP address, internal IP address, tenure, account type, and location.

GLOSSARY

"Service Provider" is defined as a person or legal entity providing digital services or content to subscribers (end users).
