METRICS AND GLOSSARY

Destination means an endpoint or end execution platform to which Oracle Data is delivered or from which data or derivative data products are collected for the purposes of Targeting, optimization, analytics, measurement, maintenance, or media application use.

Profile(s) is a unique record submitted for ingest into your hosted environment.

Oracle Data means third party data, consumer data collected by Oracle, and derivatives thereof, licensed or made available to You, by or on behalf of Oracle pursuant to the Master Agreement. Oracle Data includes, but is not limited to, data analytics, Segments, and audience data.

Oracle Data Collaboration for Advertisers, Standard – Instance

Applicable Part #B97222

Description of Services: This Service gives You access to the Oracle Data Collaboration for Advertisers hosted environment that include the following capabilities:

- 1. Ability to manage Your uploaded data as follows:
 - Data ingestion: the ability to ingest data using functionality such as: direct upload, connection of data storage locations. (Full list of current capabilities in Program Documentation)
 - Data management: the ability to manage Your data using functionality such as: data deletion, and data combinations. (Full list of current capabilities in Program Documentation)
- 2. Access to hosted environment features such as:
 - Audience building: the ability to use single sets of data, or combine multiple sets of data, to create audiences for the purpose of targeted advertising.
 - Use of shared or licensed data
