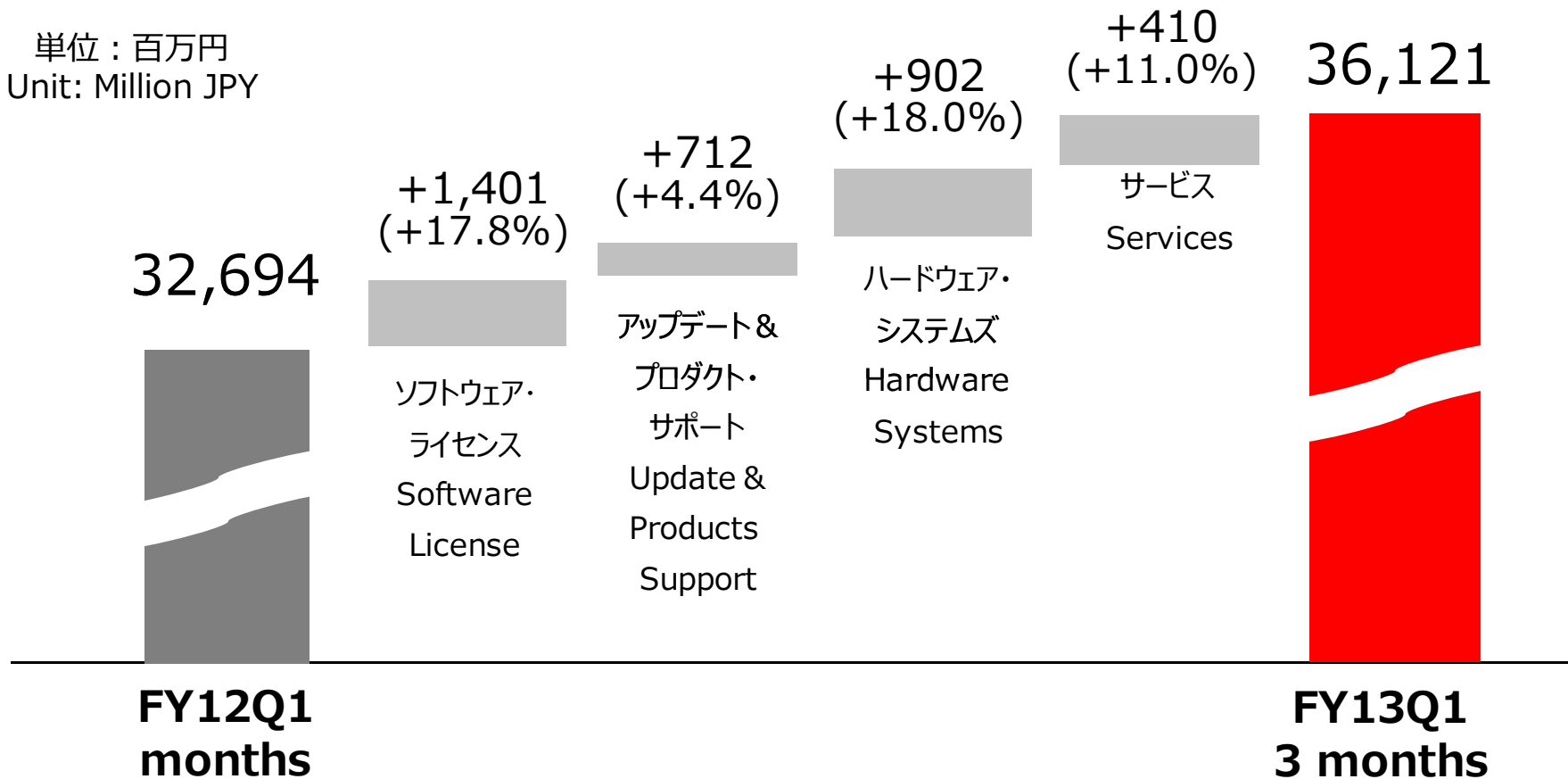

1.売上高対前年同期比 Revenue YoY

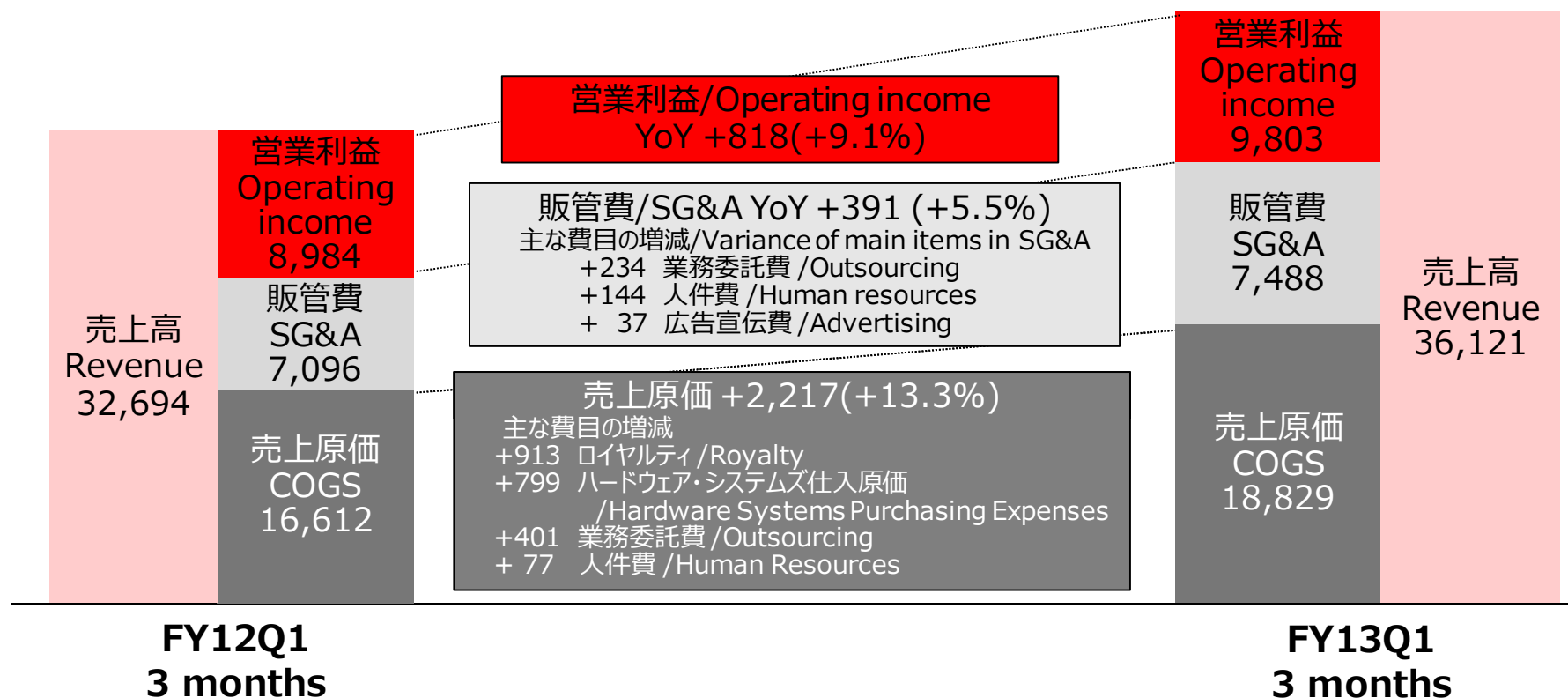

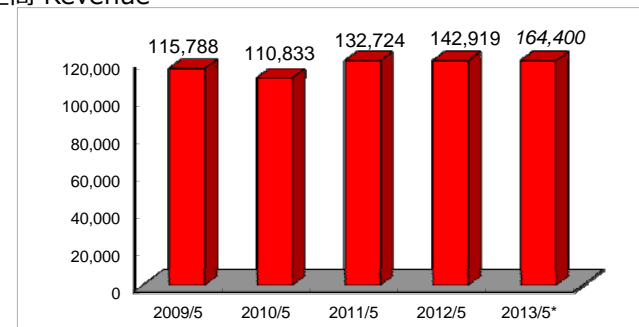

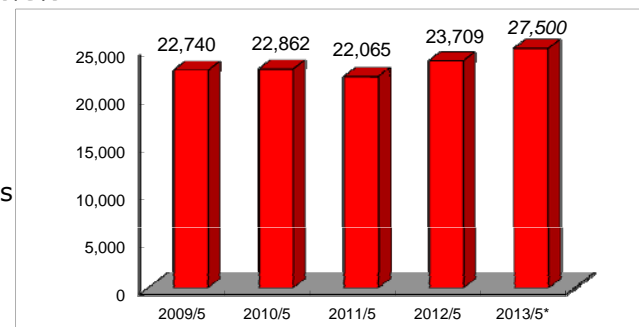
