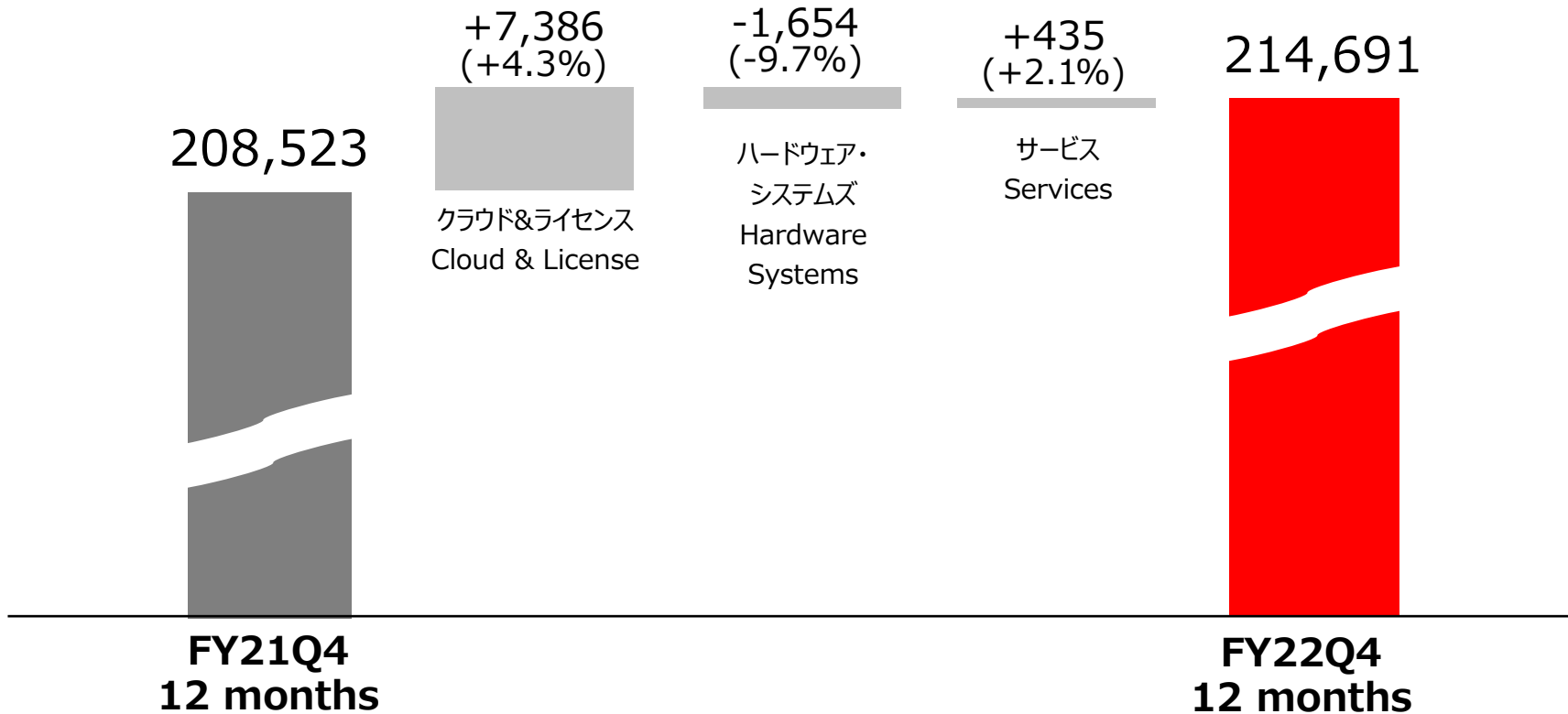

# 1. 売上高対前年同期比 Revenue YoY

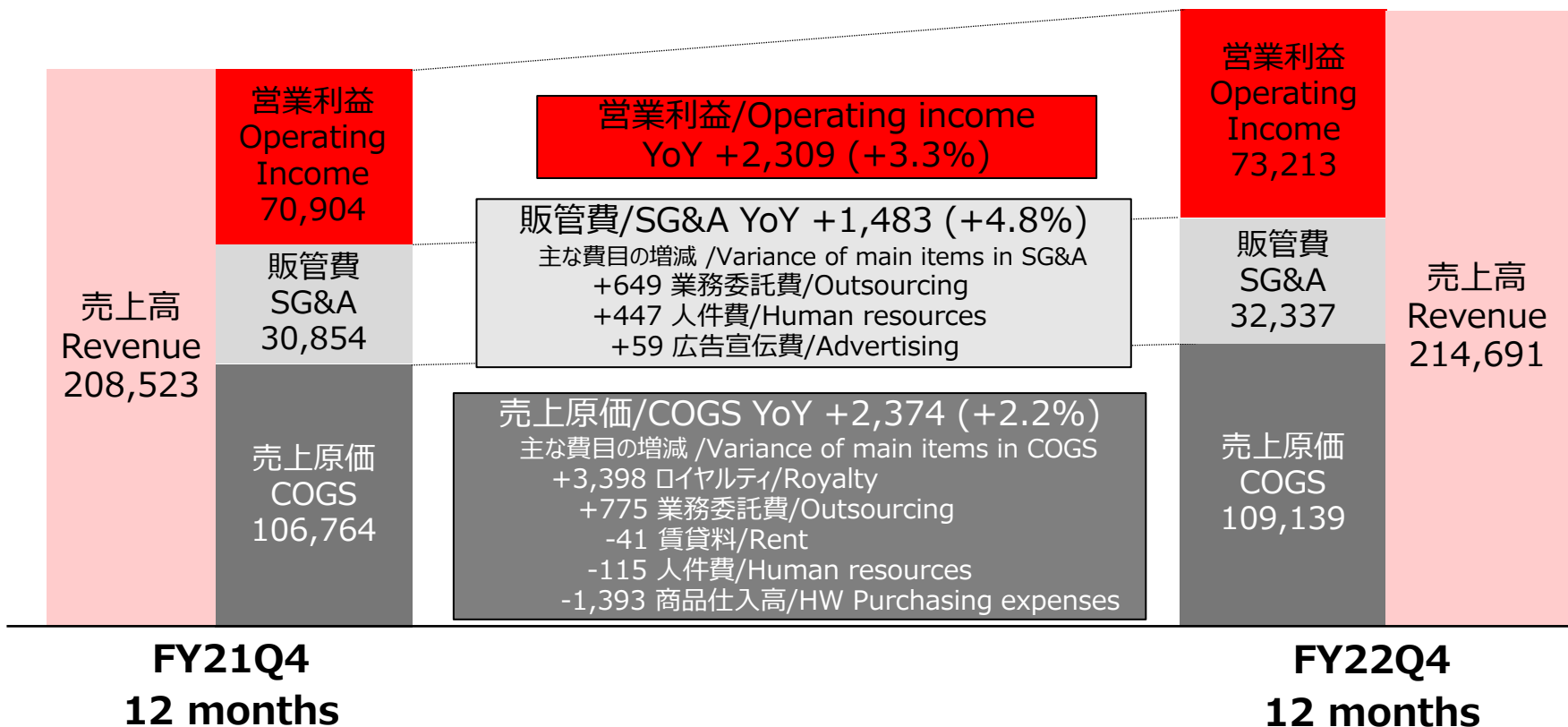

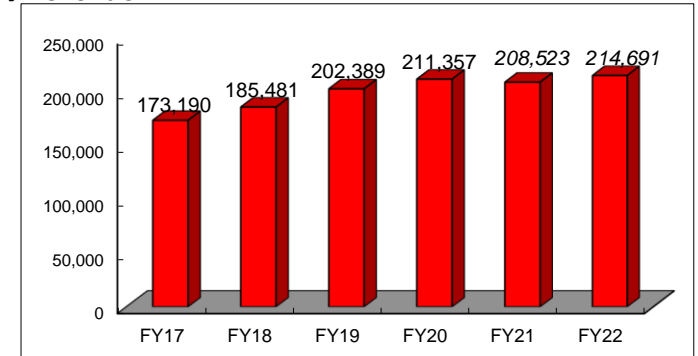

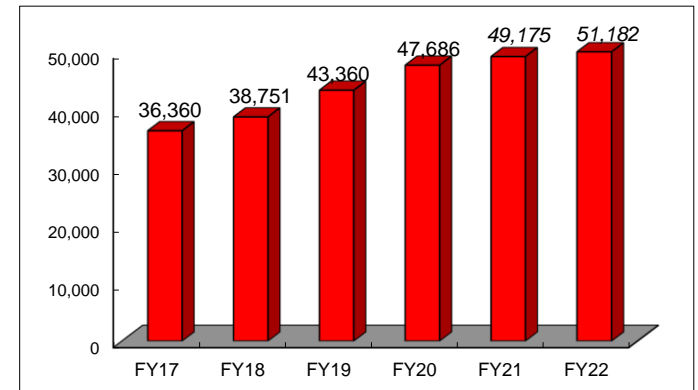
