#### **METRICS AND DEFINITIONS**

**"1,000 Active Members"** is defined as 1,000 members of a single loyalty program running on the Cloud Service where each enrolled member has a member status of Active. Any enrolled member that is flagged with a Deactivated status will be considered inactive and will not count as an Active Member. If an individual is enrolled separately in more than one loyalty program operated by You on the Cloud Service, the individual is counted separately as a unique Active Member for each loyalty program in which they have enrolled and have not been deactivated.

**"10,000 Receipt Scans"** is defined as 10,000 receipt scans, where each receipt scan is defined as a single image scan processed by the Cloud Service. Any unused purchased receipt scan will not rollover into the next contract term.

**"Each"** is defined as a single service requested. You may request these services multiple times and will pay for each service per request.

"Instance" is defined as a single deployment of the application.

"Core of Analytics Compute Capacity" is defined as the CPU capacity equivalent of one physical core available to use by the Cloud Service in a calendar month.
