Oracle Validated Integration provides customers with confidence that a partner's integration with an on-premises Oracle application is functionally sound and performs as designed. This can help customers reduce deployment risk, lower total cost of ownership, and improve the user experience related to the partner's integrated offering.

- Invoice adjustments and cancellations
- Quotations
- Sales order entry and booking
- Shipping execution

During tax calculation, Oracle transaction data will be collected from the order-to-cash tax interface view and passed to PinPoint. Integration with PinPoint provides the opportunity to gather additional business-specific information prior to invoking PinPoint. The information flows between Oracle software and the PinPoint solution, recording the tax result with corresponding jurisdiction details. The integration reads the data from the order-to-cash tax interface view, prepares the data in the form of an XML SOAP request, and uses the standard Oracle Database XML integration to send and receive the response from PinPoint. The integration utilizes multiple database objects to provide layers of communication between Oracle E-Business Tax and PinPoint, as shown in the following diagram.

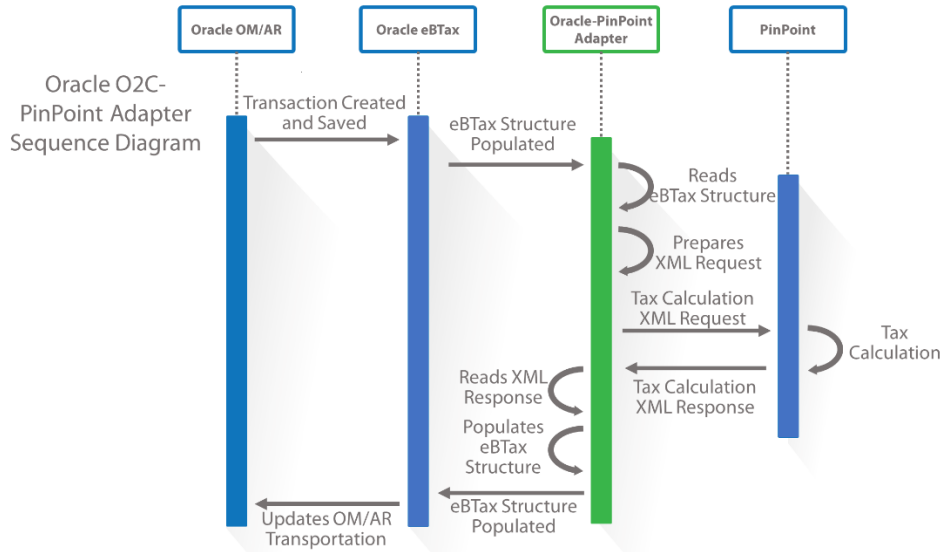


Figure 1. Architecture diagram of PinPoint integration with Oracle E-Business Suite
