INTEGRATION OVERVIEW

ONESOURCE Global Trade is composed of modules to manage import, export, exchange operations, and special customs programs (such as RECOF, REPETRO, Drawback, Temporal Admission, and others) that integrate with Oracle E-Business Suite 12.2.

ONESOURCE Global Trade facilitates the procure-to-pay process for materials acquired from international vendors. It also integrates with government systems to control the logistics and legal and financial processes required when importing goods, such as integration with inventory, purchasing, accounts payables, general ledger, and Brazilian-integrated receiving and order management for material returns.

The solution additionally supports the order-to-cash process for goods sold to international customers, integrating with government systems to control the logistics and legal and financial processes required when exporting goods, such as integration with inventory, order management, accounts receivables, and general ledger.

Finally, ONESOURCE Global Trade helps with the control of fiscal benefits—such as available tax exemptions for importing or exporting operations—integrating with Oracle E-Business Suite modules for inventory, bills of materials, and discrete and process manufacturing.

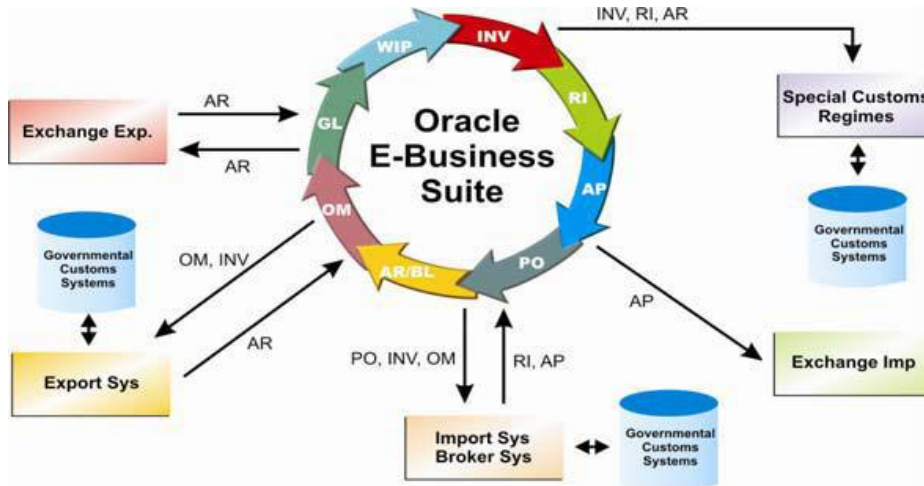
Oracle Validated Integration provides customers with confidence that a partner's integration with an on-premises Oracle application is functionally sound and performs as designed. This can help customers reduce deployment risk, lower total cost of ownership, and improve the user experience related to the partner's integrated offering.

INTEGRATION DETAILS

The integration between ONESOURCE Global Trade and Oracle E-Business Suite is based on Oracle Fusion Middleware components, such as Oracle BPEL Process Manager, which is part of Oracle SOA Suite. During integration, Oracle BPEL Process Manager orchestrates a message exchange between ONESOURCE Global Trade and Oracle E-Business Suite.

For interfaces integrating from Oracle E-Business Suite to ONESOURCE Global Trade, Oracle BPEL Process Manager starts the process following a transaction with the notification architecture provided by LAD localization from Oracle E-Business Suite. Based on these notification messages, the process is designed to obtain additional data from enterprise resource planning (ERP) to do the data mapping and notify ONESOURCE Global Trade web services.

When a transaction is performed with ONESOURCE Global Trade, a message is sent to Oracle BPEL Process Manager, which begins the process of querying ONESOURCE Global Trade APIs for additional data, performing data mapping, and initiating Oracle E-Business Suite. This notifies an API or saves records in open interface tables.
