The innovative design and configuration options of Vertex Tax Links allows tax departments to take control of tax decisions and make changes that affect their company's compliance with minimal IT assistance. Through this connector, Vertex Tax Links users are given full access to Vertex's reporting and remittance tools that help streamline compliance processes by:

- Increasing accuracy of tax information and auditability of tax data.
- Streamlining processes for personnel maintaining JD Edwards EnterpriseOne and Vertex O Series tax solutions (Vertex Indirect Tax O Series 9.0/Vertex Indirect Tax O Series On-Demand 9.0/ Vertex Cloud Indirect Tax).
- Removing tax decisions from nontax personnel.

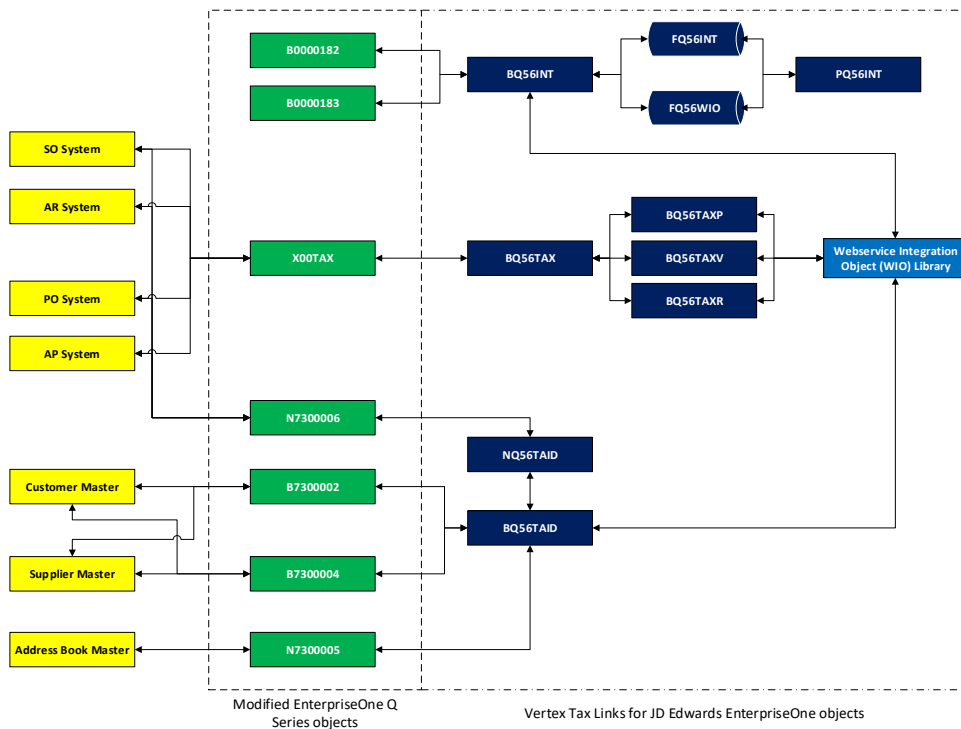

Series tax calculation engine. Once Vertex Tax Links has been installed and configured, the information passed from JD Edwards EnterpriseOne is mapped to the appropriate Vertex O Series parameters for processing by the tax calculation or tax area ID services; the result is returned to JD Edwards EnterpriseOne.

Vertex Tax Links enables JD Edwards EnterpriseOne and Vertex O Series users to:

- Retrieve and assign tax area IDs for more accurate tax jurisdiction codes.
- Address cleansing and latitude or longitude support when assigning tax area IDs.
- Calculate and apply proper tax to sales and procurement transactions.
- Provide configuration flexibility for integration.

Note: Vertex Tax Links connects JD Edwards EnterpriseOne to Vertex O Series solutions. The purpose of this is to avoid changes to the core application business objects for JD Edwards EnterpriseOne modules—Sales Order Management, Procurement and Subcontract Management, and Financials. This reduces implantation time and maintenance costs associated with applying bug fixes or enhancements provided by Oracle.
