## **Appendix I**

Oracle China Personal Information Notice and Consent Appendix to the Oracle Recruiting Privacy Policy

- Sensitive Personal Information: Despite the general categorization in the Privacy Policy, you are hereby informed, understand and agree that in most cases, personal information we collect about you is not considered sensitive, but in limited circumstances, we may collect personal information that fall in the "sensitive" category under PIPL.

In any case, we will make sure that the processing of your personal information is for specific purposes as described in the Privacy Policy and is necessary, and our processing of your sensitive personal information will be subject to strict security measures and be conducted in a manner having the least impact on your personal rights and interests.
