




Figure 1: The EDQ Siebel Connector used with Oracle Watchlist Screening



Case Management Improvements Reports and filters


- Instant searching and operational reporting for large data volumes
- Aggregations (banding) in reports
- Search on history
 - Find all cases commented on by user
 - Find all cases transitioned in workflow by user
- Use negative search logic
 - Find all cases where value is NOT x



Case Management Improvements

Workflow enhancements

- Availability of transitions in workflows can be controlled using flexible conditions
 - Based on case/alert status
 - Whether the user has made 'blocker' transitions
- Allows enforcement of a '4-eye' review process, even where users have full permissions
