Single Electricity Market Operator (SEMO), is the Market Operator for the wholesale electricity market on the Island of Ireland.

SEMO has the responsibility for the ongoing maintenance and support of business critical systems essential to the market. This includes the Central Market Systems that provide the scheduling and settlement function for the Single Electricity Market (SEM); Reserve Constrained Unit Commitment and the Auction Management Platform for both the Moyle and the East West Interconnectors. The seamless operation of these systems are essential to participants and ensure the smooth running of the market.

Operate within stringent KPI's.

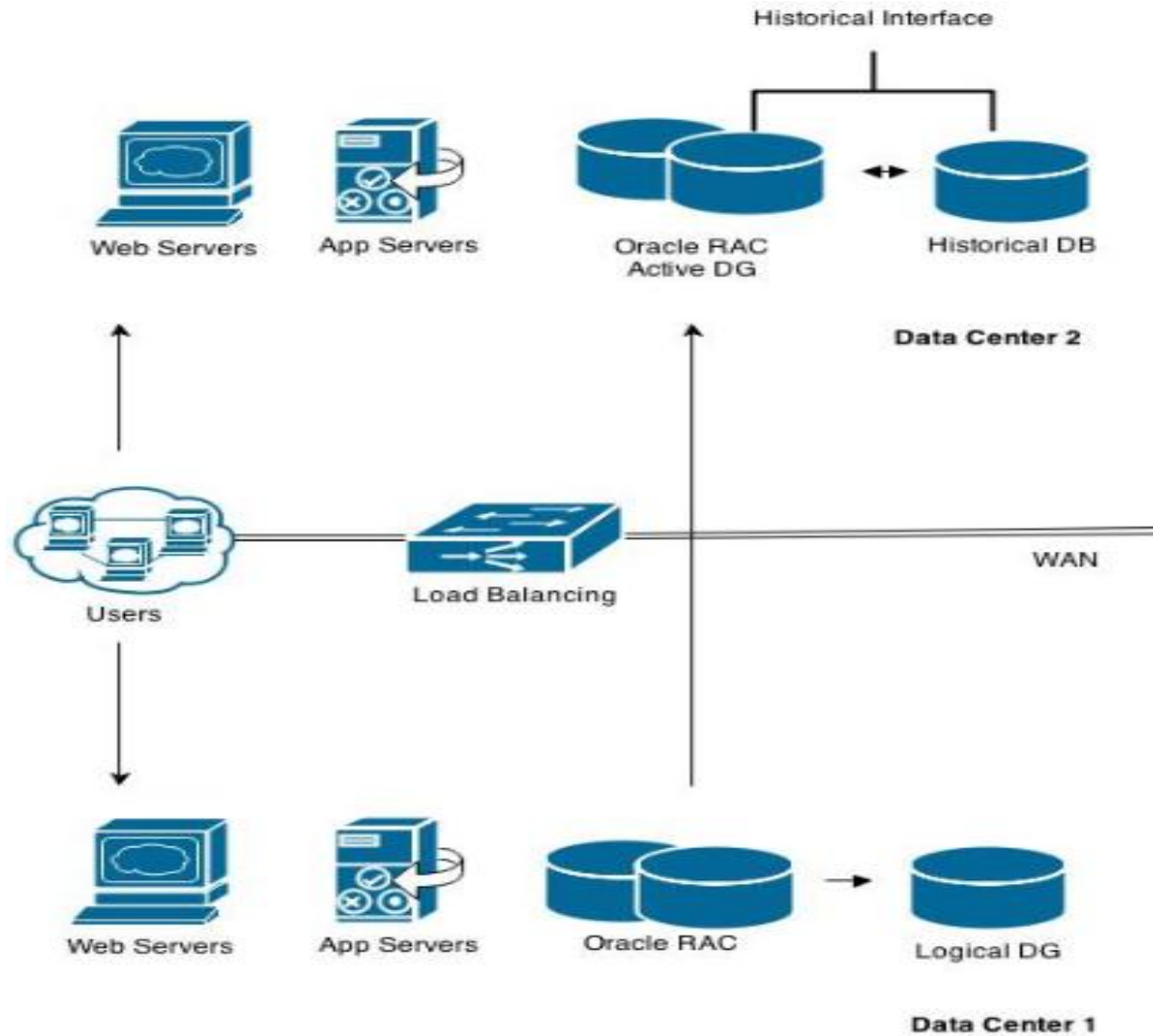

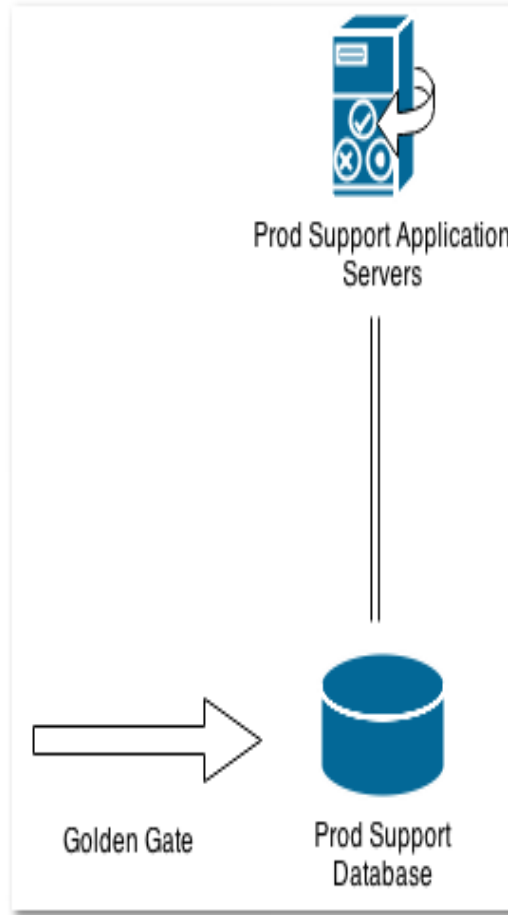
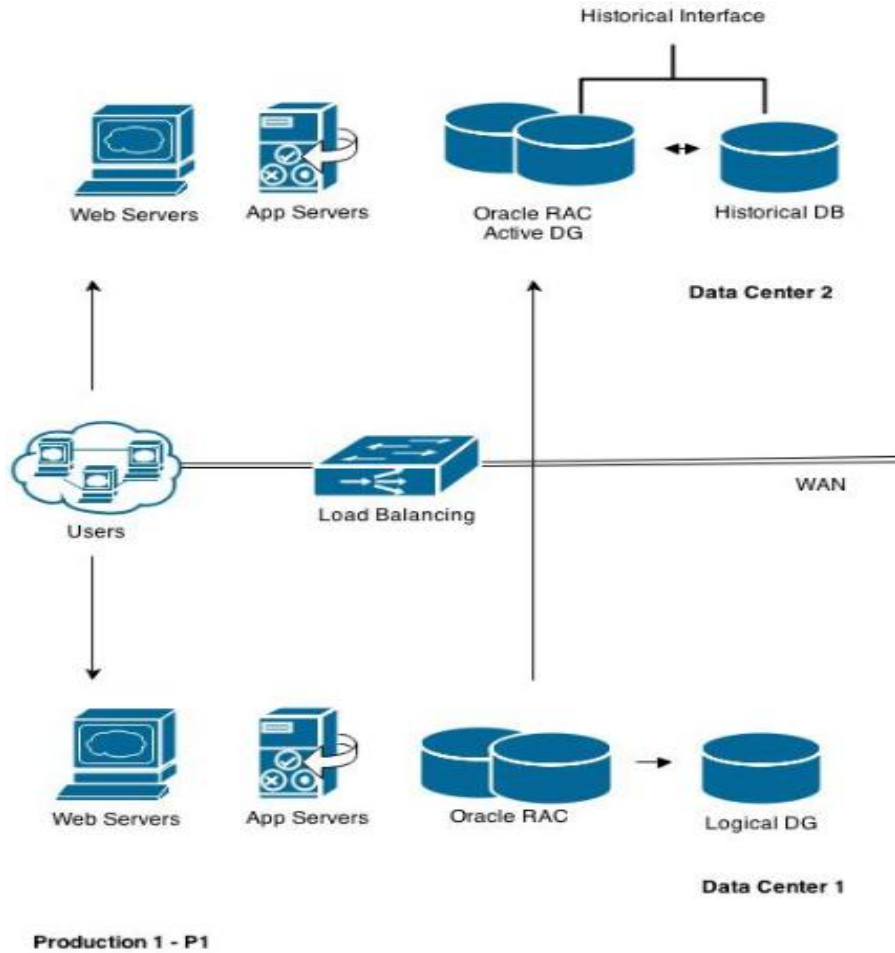
SEM has a requirement to deliver bug and data fixes within hours of the event. This requires:

In Sync Prod Copy of a 3TB database.

Ability to roll the database backward and forward to reply the event.

Real Time Replication : Bug & Data Fixes

- Oracle Golden Gate
- Oracle Flashback Database
- Oracle Golden Gate Veridata
- 12c Cloud Control



Stage 1 : Open GG Environment

- Stop GG Replication
- Create a GRP
- Start Prod Support Apps
- Wait until Bug Data fix resolution

Stage 2 : Sync GG Environment

- Isolate DB from Apps
- Flash database back to GRP
- Start GG Replication

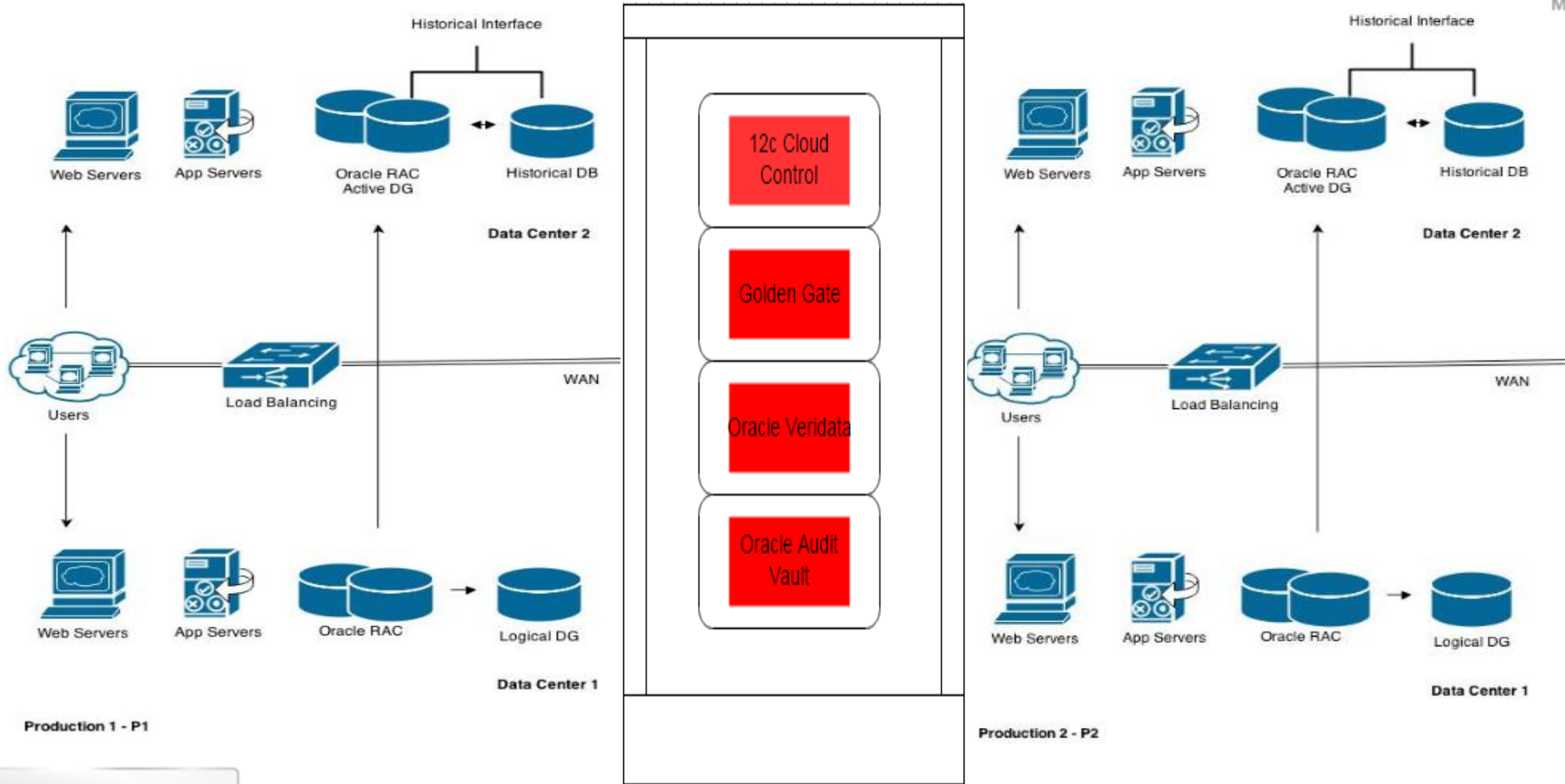
3rd Bi Annual Releases : Private Cloud
